## 1. OFFER AND ELIGIBILITY

The Promotion is available at Ashburton Pool and Recreation Centre, Bellbird Park Indoor Centre, Benalla Aquatic Centre, Boroondara Sports Complex, Brunswick Baths, Coburg Leisure Centre, Hawthorn Aquatic and Leisure Centre, Horsham Aquatic Centre, Macleod Recreation and Fitness Centre, Numurkah Aquatic and Fitness Centre, Oak Park Sport & Aquatic Centre, Peter Krenz Leisure Centre, RecWest Footscray, South Gippsland SPLASH, Warragul Leisure Centre (Participating Centres) between the dates of 3 June 2024 to 31 July 2024 (Promotion Period).

  - ii. To qualify, you must;
    - 1. be a new member and not an existing member at the relevant Participating Centre
    - 2. not have activated the free 7-day trial
- d. Offer 2(a) and 2(b) are is valid for Health and Wellness memberships, Aquatic memberships, and Active Adults memberships only (not available for youth memberships, stadium memberships, or corporate memberships).
